Agenda & Discussion

Topic 1: Member Appreciation Match (MAM)

- Discussed the potential for a raffle at the MAM.
- Considered reallocation of funds toward replacing and purchasing props and a new Conex instead of raffle expenses.
- Consensus favored spending on SDPS inventory improvements with a small gift for attendees.
- Motion: Phil Zidek moved to set aside \$500 for member gifts, amended by Carlene Ellis to limit the number of gifts to 100 based on prior attendance.
 - Seconded by: Dave Hong
 - Motion approved.

Action Items:

- *Ryan Harrigan* – Research the cost of 100 MAM gifts.
- *Marty Johnson* – Obtain estimate for meat from Swingles.

Topic 2: Western 2026

- Discussion on providing compensation for staff traveling more than 100 miles.
- The Board agreed to create a compensation plan once staff names and travel distances are known.
- Topic tabled until travel details. Compensation will be based on 2025 Western income

Topic 3: Replacement Conex

- *Phil Zidek* is obtaining vendor estimates for replacing Conex 1.
 - 40' unit with end door: approx. \$2,000–\$2,500
 - 40' unit with roll-up side door: approx. \$4,300
- Old Conex removal will require ground prep (gravel, railroad ties, or concrete piers).
- Coordination will be needed with Folsom Shooting Club (FSC).

- Discussed the possibility of relocating Conex 2 and temporary storage of current contents.
- Disposal of old Conex may yield scrap metal value.
- Motion: Dave Hong moved to approve \$7,000 for purchase and installation, including site prep and disposal.
 - *Amendment by Ryan Harrigan* to include contingency up to \$10,000 total, starting at \$7K.
 - Seconded by: Dave Hong
 - Motion approved.

Action Item:

- *Phil Zidek* – Coordinate with FSC regarding moving Conex 2 and placing the new Conex.

Topic 4: New Props and Steel

- Current prop inventory is available on the SDPS website for Match Directors.
- Emphasis should be placed on using the equipment listed to avoid borrowing from other clubs.
- Proposal: Purchase additional equipment:
 - 2 large poppers @ \$387 each
 - 2 weighted clamshells @ \$350 each
 - 2 forward fall kits @ \$72 each
- The BOD approved the purchase of the equipment.
- Motion: Phil Zidek moved to approve \$2,000 for equipment needed for Western and club matches.
 - Motion tabled.
